I live adjacent to the Pump House and have observed its decline due to prolonged disuse, as well as recurring litter left by small groups, who sometimes gather in the area behind it.

The aim of the Ferring Men in Sheds charity is to provide local residents with a much-needed space to share skills and contribute to community projects, helping to foster a stronger sense of local identity, pride, and purpose. I believe this proposal would represent an excellent and constructive use of the Pump House and the surrounding area.
