I would like to register my support for the proposal to develop a Men in Shed's workshop at Glebelands Recreation Park.

The Men in Sheds charity is recognised worldwide as a vital community asset which promotes mental and physical wellbeing, combating social isolation, by providing a space for forging connections and enhancing community cohesion.

The provision of this space for crafting, practicing and developing woodworking skills can also provide practical help in addressing some of the needs of other community projects.

This central Ferring location is ideal to encourage physical exercise to access the workshop, both by bicycle and walking.

This type of facility is currently lacking in this area and its development would help fulfil the council's objectives for the provision of health and social cohesion community projects, whilst also engendering a stronger sense of local identity and purpose.
