Thank you for your internet representation made on 26th February 2025 which has been recorded as an objection with the comments as follows:

OWPC74565

I object to the illumination of the sign advertising the Retirement Home because it is right at the entrance to the historic Ferring Conservation Area, which needs to be protected from such intrusions. The illumination (and the very prominent sign itself) serves no public purpose - the earlier signage is more than adequate for public information. The illuminated sign is for a commercial purpose, which is not appropriate for this location. - Ed Miller

In the event of a subsequent written representations appeal, against a refusal of advertisement consent any representations made on the application will be automatically forwarded to the Secretary of State. Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
