Thank you for your internet representation made on 4th April 2025 which has been recorded as an objection with the comments as follows:

Has there been a mistake with this application? In the application there is a signed declaration saying that the land to which the application relates to is wholly owned by the owners of no1. This land is defined by the red line. The drawings show the fence line comes out to the kerb beyond the existing fence and bushes even takes in the muddy bit where there is no made road. This would be very imposing on the road and houses opposite this current proposal.

As it stands every planning application in Ferring would include a site boundary back to sea lane which of course they don't.

Your views as made above will be considered before the application is determined.

Please be aware that Planning Services operate an 'open file' policy and will publish your comments including your name and address on the website. Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
