Description of works: Demolition of the existing garage and replacement with new store and residential annex to the main house.

Thank you for your internet representation made on 7th October 2025 which has been recorded as an objection with the comments as follows:

I have no technical/building knowledge but I really feel that this build must not be passed.

Eaves is over 100 years old and I would expect that the foundations of this property are very close to the boundary fence.

With what I can make out of the drawings the new plans are to dig down for new foundations for the proposed dwelling.

:foundation being up to 1.5 metres deep will cause disruption to the foundations of Eaves.

:Using the whole plot will also make the new dwelling extremely close to Eaves.

: I wonder how concrete lorries, and builders will get up this narrow lane and where will they park whilst doing this build. I expect everyone thinks its ok to just park outside of Eaves and block the drive.

: I wonder what the use of the new dwelling will be as the Old watch house already have 4/5 bedrooms.

: The ecological enhancement point is absolutely ridiculous. Adding a bee box after ripping all the grass up to build a dwelling is a joke.

: There in no room on the plot. The lane is as packed as it should be. If this bit of grass is taken away from the top of the lane it will be an eyesore. There is no reason at all there needs to be another 3 bedroom dwelling in this tiny space.

: I feel that if the applicant cared about Bees and flowers her own garden would be full of bee boxes and plants.

I am seriously worried about the impact of Eaves and also the cottages that face the planned dwelling. The new foundations will impact these properties and for no good of this close community.

Your views as made above will be considered before the application is determined.

Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
