Thank you for your internet representation made on 3rd April 2025 which has been recorded as an objection with the comments as follows:

OWPC75214

The boundaries on the estate must have a green border in front on them and are not allowed to be sited right up to the pavement. Other properties have put in planning before erecting fences and all have been denied unless there is a gap between the fence and the pavement, which should have either grass or a green hedge in front of it. The parish council have also denied applications on this basis.

Your views as made above will be considered before the application is determined.

Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
