Thank you for your internet representation made on 20th April 2025 which has been recorded as an objection with the comments as follows:

OWPC75872

I would not have objected to a single garage next to the bungalow to replace the garage being lost with the extension. However, the replacement garage is huge with a pitched roof which is an over development of the plot and is out of character with the area.

I also do not understand why the garage is to be built so far away from the property at a completely different angle from the road.

As the applicant has already requested a bungalow on the site and then a huge storage facility which looked like a bungalow, I feel that the position of the garage and the size is for the intention of changing the usage in the future to a dwelling, which I assume would be more likely to be passed once a building is already present.

Also, there are no yellow signs advising the resident's of the application.
