Site Address: Land at Ford Airfield Ford

Description of works: Approval of reserved matters (layout, scale, appearance and landscaping) following outline consent F/4/20/OUT for the infrastructure reserved matters including the provision of a primary spine road and associated secondary road junctions, pavement, footpaths, cycle infrastructure and bus stops; site wide drainage infrastructure including foul pumping stations, foul sewer infrastructure, SUDS basins, SUDS swales, surface water infrastructure; acoustic fencing; public open space including landscape details, play areas, footpaths & associated works. This application affects a Public Right of Way, may affect the setting of a Listed Building and falls within CIL Zone 1 (Ford strategic site - zero rated).

Thank you for your internet representation made on 29th October 2024 which has been recorded as an objection with the comments as follows:

Clymping issues extracted as follows. Clymping Parish Council submits a rejection due to lack of information and implications for communities outside development

Foul and service water drainage:

1. Where is the maintenance agreement for the SUDS?
2. The Plan relies upon surface water discharge to private drains outside of the site. What is the agreement with the landowner to maintain these drains?
3. Pumping stations 1 to 3 feed into 4. There is no mention of a backup should these pumps fail. Is this planned?. In light of the recent sewage leaks locally the pumping stations should all have more than just 'greencrete' vehicle access, and could you confirm they are capable of receiving articulated tankers?

Transport

1. With the speed of traffic along Church Road, should this not be an opportunity to install 'controlled' junctions
2. How will the PROWs be maintained throughout the build programme to ensure access for residents is maintained? The current Temporary Closure Notices states that the paths will be closed for up to 6 months. This is not acceptable as these routes are used by residents to get to work as well as for leisure purposes. How will all of the PROWs be maintained?

3. The list of active travel modes does not include a new footpath from Yapton Road along Horsemere Green Lane but claims to be included in the S106 Agreement. Why the exclusion

Your views as made above will be considered before the application is determined.
