
Recent correspondence states Footpath (FP)200_3 will need to be diverted across the top of the newly extended SUDs basin. The diversion will need to be applied for through Arun District Council and approved before any temporary closure can be applied for in advance of works being carried out. Please note the surface must be approved by West Sussex County Council PRoW team as we will continue to be responsible for its upkeep.
