## F\_14\_24\_RES - IRM Amendments

Couple items to note regarding the document/drawing list register:

1. We've reviewed all documents on the ADC register and split the register into three primary columns to ensure the correct documents have been uploaded
  - a. **Left Columns** - Final Plans/documents alongside reference/revision numbers
