Description of works: Approval of reserved matters (layout, scale, appearance and landscaping) following outline permission F/4/20/OUT for phase reserved matters1 (North), for the erection of 340 No. residential dwellings plus associated roads, infrastructure, parking, landscaping, open space & play areas and associated works. This application affects a Public Right of Way, may affect the setting of a Listed Building and falls within CIL Zone 1 (Ford strategic site - zero rated).

Thank you for your internet representation made on 17th October 2024 which has been recorded as an objection with the comments as follows:

OWPC71821

Whilst I do not object to the overall plan I feel that there are some areas of concern.

- The IRM section is quite large. Could some of this be incorporated into RM2 to make more of a feature of the canal area?
- Footpath 363 is shown as a green corridor but will the existing mature trees be retained or cut down and replaced by smaller vegetation?
- There is local annoyance about closing footpaths while work continues for several years. It is hoped that public access can be retained across the site by careful fencing.
- the naming of the 'St Mary's Meadow' green area is confusing as it conflicts with a road of that name in Yapton. Maybe change to St Mary's View?

Your views as made above will be considered before the application is determined.
