Clymping Parish Council objects and raises the question regarding Para 5.7 of the transport submission, it is proposed widening of the existing footway to provide a 2.5 to 3m wide pedestrian/cycleway. How is this achieved? How will the path cross the extremely busy Church Lane to access Horsemere Green Lane?
