Further to my email of 16th December 2025 at 15.45, I would like to clarify the following point:

Environmental Health recognise that an acceptable acoustic environment can be achieved internally for all dwellings, but only when windows are closed. Having to have windows closed in this environment to achieve an acceptable internal acoustic environment forms the basis of Environmental Health’s continuing objection.

Given that there will be alternative external amenity areas, Environmental Health are satisfied that the 12 flats with private balconies where the external noise level will not be compliant, is acceptable.
