I am concerned that this is still being considered despite numerous objections. Rollaston Park is already an extremely busy road leading up to the Flying Fortress especially at weekends with the market as well. During the week it is busy with huge lorries back and forth. I cannot see the roads coping with even more cars, two or three cars per house. So this all needs to be stopped and this is ridiculous for existing residents in the area.
