RE: F/16/24/RES – Land at Ford Airfield, Ford, West Sussex

Thank you for your consultation on the above site, received on 01 October 2024. We have reviewed the application as submitted and wish to make the following comments.

Approval of Reserved Matters following outline permission F/4/20/OUT for Phase Reserved Matters 4 (south), for the erection of 357 No. residential dwellings plus associated roads, infrastructure, parking, landscaping, open space & play areas and associated works. This application affects a Public Right of Way, may affect the setting of a Listed Building and falls within CIL Zone 1 (Ford strategic site - zero rated).

The applicant has provided a Flood Risk Assessment (FRA), Drainage Strategy and additional information to account for the local flood risk issues and surface water drainage at this location. Following a review of the submitted documents, the details are in accordance with NPPF and local planning policy W DM2.

We have no objection subject to conditions 29, 30, 31, 32 of Decision Notice F/4/20/OUT fully discharged as they relate to surface water management and drainage.

Informative:

Structures or any culverting of an ordinary watercourse requires consent from the appropriate authority, which in this instance is West Sussex County Council. It is advised to discuss proposals for any works at an early stage of proposals.


