Many thanks for the mail and apologies I couldn't make the advisory group meeting, unfortunately I already had meetings that couldn't be altered.

The current catchment school for the application is Yapton which as you say is currently over subscribed, it is however due to be expanded and whilst our Planning School Places document says for 2026 we have been advised that this is now scheduled for 2028.

The Ford Landings development does have provision for a new 2 form entry primary school within the signed S106 agreement. The recent application for 400 dwellings adjacent to the Landings development, with the land allocation for a secondary school is a windfall application which, should the application be approved, be required to make contributions through CIL for primary education provision.

I do hope this answers your questions, please do not hesitate to come back to me if needs be.

The WSCC planning school places document suggests there is insufficient capacity at primary.


