Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

I live in the private estate immediately behind, the roads are flooded and always backed up with the already overcrowded new developments. Also there will be significant car parking for school runs and pedestrian footfall and with that, anti social behaviour in our private estate through existing public footpaths which is already a busy estate with limited road space. It would make it significantly dangerous.
