Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 28th July 2025 which has been recorded as an objection with the comments as follows:

OWPC77891

- 1) There is so much development over the 5 Villages, and there is no infrastructure to support it.
- 2) Roads are very dangerous due to sheer amount of traffic on roads now.
- 3) You will be building on agricultural land: with rising costs of food and instability around the world. Do we really want to build on a field that can provide us with food for cheaper than importing it.
- 4) This area is a flood plain and all the extra building has made flooding everywhere (including main roads). Last year the village was essentially cut off for a day due to flooding.
- 5) the project is too close to our church building - which is very old. Despite the green area due to next to it - the vibrations from the nearby building work will cause damage to the church building.

Your views as made above will be considered before the application is determined.
