Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 11th July 2025 which has been recorded as an objection with the comments as follows:

I object to this. Alongside to the new builds they are calling the Landings which will be alongside it, and the other newbuild estate the other side of it, it all amounts to approx. 2,000 homes. This is beside all those built along the North End Road. It is all being built very, very close to the church which must be protected. The village has grown so much in just 12 years with the new builds proposed we would have the population of a town. And we will be a town with a butcher, a Co-op, chemist, doctors surgery, one pub and a small school. Our narrow roads are already unsafe because of the amount of traffic. The water company I would suspect have difficulty coping with the extra people. Most people that move here come from London, so it isn't for local housing need there are currently a minimum of 97 homes for sale in Yapton this week.

Your views as made above will be considered before the application is determined.
