Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 11th July 2025 which has been recorded as an objection with the comments as follows:

OWPC77595

This development is totally unsubstanable due to amongst other things it's location.400 houses plus the 1500 houses proposed for The Landings will not only choke up the surrounding roads but will also severly overload the utilaties which are at present beyond capacity.

The proposed Secondry school would be a 35 minute walk to Ford Station an a 18 minute walk to the nearest bus stop.

Ford Lane and Ford Road are both minor roads and are constantly jammed with cars and HGV's. If each house has 1 car that's 1900 extra cars emptying on to the local roads.

I strongly object to this proposal.
