Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 14th July 2025 which has been recorded as an objection with the comments as follows:

OWPC77625

There is no mention of new public transport provision, cycle networks, or footpath improvements. Nor is there an indication of healthcare, retail, or community facilities to support a development of this magnitude - contrary to WSCC's Infrastructure Delivery Plan requirements.

At the Arena, the transport guys also said there were no plans or budget to improve cycle or footpath access. Combined that with our developer has already 'post changed' and ignored their submitted plans, I'd be concerned that will happened again. Promises of improved access and ultimately none.

Your views as made above will be considered before the application is determined.
