Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 14th July 2025 which has been recorded as an objection with the comments as follows:

10. Non-Preferred Site with No Justified Educational Need

According to the 2023 WSCC Secondary School Site Selection Study, clearly not preferred or favoured. It was also done again prior to Landings approval.

It scored poorly on accessibility, environmental impact, and integration with existing settlements. The proposal provides no compelling evidence of current need for a school of this scale in this location, nor does it address why higher-ranked, more sustainable sites were dismissed.

May I also add that Yapton Primary School has also been proposed to be developed and extended and this along with the landings has not yet happened so again I object to the fact that Yapton requires this three storey school.

Your views as made above will be considered before the application is determined.
