Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 14th July 2025 which has been recorded as an objection with the comments as follows:

Ford lane is narrow and not designed to handle the volume traffic this and the Ford development will load onto the lane, the current doctor surgery is full are there plans to add more capacity. We already have over a thousand new homes in yapton, with this and the Ford development will add another 2 thousand properties without any major infrastructure upgrades to support it.
