Site Address: Land to the South of Ford Lane Arundel BN18 0DF
Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 14th July 2025 which has been recorded as an objection with the comments as follows:

OWPC77639

NOT in order of importance:

1. 3-storey building is FAR too high.
2. School too near to existing houses with inappropriate access to the private estate (Emerald Gardens).
3. Traffic and parking congestion will be unmanageable and cause damage to pavements and road.
4. The road is too narrow to accommodate parents parking to collect children.
5. If the school is to be approved, it should be at the entrance to the development on Ford Lane to avoid unnecessary traffic through the new development!
6. 1500 houses are already being built 200m away (as the crow flies) so this 400-houses development is totally unnecessary.
7. There is no industries in the area to provide work to people moving into the area.
8. And, very importantly, farming and agricultural land is being given up for housing that has not been proven as required in this area!

Your views as made above will be considered before the application is determined.
