Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 15th July 2025 which has been recorded as an objection with the comments as follows:

OWPC77641

3-storey building is far too high. School too near to existing houses with inappropriate access to the private estate (Emerald Gardens). Pathways being built that lead to existing footpaths. Traffic and parking congestion will be unmanageable and cause damage to pavements and road.

The road is too narrow to accommodate parents parking to collect children.

5. If the school is to be approved, it should be at the entrance to the development on Ford Lane to avoid unnecessary traffic through the new development!

Your views as made above will be considered before the application is determined.
