It is difficult to get in and out of the village already with lots of new houses with cars and constant road works. If it rains we have floods as the drains cannot cope. The Doctors have closed the books as they are inundated so it is very difficult to find a Doctor. Yapton is smothered as it is without more houses, people and cars etc
