Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 15th July 2025 which has been recorded as an objection with the comments as follows:

We moved to Emerald Gardens 9 years ago to what we considered a small development in a village. Now with all the developments to the Airfield and Noth Lane, Ribank, the village is now a town. This is unsustainable for sewage, road size and infrastructure and the threat of flooding , coastal erosion. How can the council allow this village to become a conurbation. Please give us some respite.

Your views as made above will be considered before the application is determined.
