Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 15th July 2025 which has been recorded as an objection with the comments as follows:

am writing to express my strong concerns regarding the continued development of new housing in and around Yapton.

There has already been a significant number of new dwellings built in the area, and it is becoming increasingly evident that the village is being overwhelmed. The existing infrastructure, including roads, public services, and particularly water supply, is already under considerable strain.

Furthermore, the ongoing closure of the public right of way - which has now been inaccessible for several months - continues to affect the entire community. It is vital that this access is restored and maintained, as it plays an important role in both local life and preserving our rural environment.

I would also like to urge the preservation of Ford Airfield, or at least parts of it, which hold historical and environmental value.

Please consider the long-term impact on the community and the landscape. No more housing developments

should be approved until the current infrastructure and public amenities are capable of supporting the existing population

Your views as made above will be considered before the application is determined.
