Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 15th July 2025 which has been recorded as an objection with the comments as follows:

OWPC77651

Further destruction to local farmland and areas for wildlife. Lack of suitable parking for school drop off and pick up. Parents will, like at so many other local schools, park in residential roads, blocking resident parking and property.

Not suitable to have a school in the middle of THREE housing estates which already have a lack of parking. The increase of traffic on small residential roads will cause major traffic which has already increased tenfold in the last ten years.

Not enough suitable infrastructure including doctor surgeries etc for a further 400 homes.

Your views as made above will be considered before the application is determined.
