Our roads have been shut off for up to a year previously to manage the gas works for all the new builds which caused chaos, the roads cant take the traffic and are in constant need of repair causing more delays.

The area can not take any more housing or another secondary school without detrimental affect to the local residents, wildlife and our villages.
