Site Address: Land to the South of Ford Lane Arundel BN18 0DF

Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 16th July 2025 which has been recorded as an objection with the comments as follows:

**1. Loss of Green Space**

The development would permanently remove large areas of open countryside and green space, altering the rural landscape and reducing access to natural surroundings for residents.

**2. Significant Harm to Wildlife**

The site includes important habitats, mature hedgerows, and wildlife corridors that support local species. The proposed development would fragment or eliminate these habitats, with "green corridors" offering poor compensation for the ecological loss.

**3. Unsustainable Pressure on Infrastructure**

Local roads, utilities, and public services are not designed to support the substantial increase in housing and school capacity.

**4. Excessive Traffic Increase**

A large secondary school and high-density residential areas will create heavy congestion on all roads around the site, particularly Ford Lane and surrounding minor roads.

#### 5. Unsafe Access to school via Navigation Drive

Proposed school access via the footpath off of Navigation Drive would route school drop off and pick up traffic through a residential estate with a single entry/exit point. Traffic would congregate on a blind bend opposite a play park used by young children, posing a serious safety hazard.

#### 6. Overbearing Three-Storey School Building

A three-storey school is out of character with the surrounding village and countryside, obstructing rural views towards the South Downs for residents south of the proposed development.

#### 7. Loss of Public Footpaths and Open Access

The development would close or divert existing footpaths, reducing walkability, outdoor recreation, and community access to nature.

#### 8. Negative Impact on local residents

Increased traffic, noise, and light pollution, as well as the impact on local amenities, will impact the quality of life for residents both during construction and beyond.

Your views as made above will be considered before the application is determined.
