Description of works: Outline planning application with all matters reserved (except access proposed along Ford Lane) for development of up to 400 No dwellings, a 8-10 form entry secondary school with associated sports pitches and facilities, a community hub building of up to 600 sqm, new pedestrian and cycle routes, Public Open Space, sustainable urban drainage system, landscaping and associated infrastructure. This application lies within the parish of Ford and Yapton, affects the setting of listed buildings, affects a Public Right of Way and is a Departure from the Development Plan. This is a CIL liable development.

Thank you for your internet representation made on 17th July 2025 which has been recorded as an objection with the comments as follows:

I would like to object to this current proposed development as a person who lives directly on the path opposite the proposed school fields I am deeply concerned about the increase in noise pollution, the increased traffic which will end up outside my house both cars and walking when people realise they can pick up or drop off and walk through as a cut through to the rear of the school. Increased ASB especially at the furthest part away from the proposed school this will increase for certain. As a shift worker this will deeply effect my wellbeing. This will also have a negative impact on my house valuation which im sure you certainly wont be offering any compensation on. Lastly and most importantly it will be through the noise and building and dust that will displace all the wildlife literally feet away from my front door, foxes, badgers, deer numerous birds nesting will all be displaced and for that reason considering 1500 houses are being built only half a mile on the airfield these 400 homes are not needed, the infrastructure will never support it. Just yesterday yapton lane was closed due to possible deep holes and everything was sent via lake lane this caused cars, buses and lorries to become stuck and at 5pm took over an hour to go from Barnham, adding a secondary school onto this current site will make the railway crossing more gridlocked. From what I have read the council already own the land in Barnham next to the current school which also has good train, road and bus infrastructure so that should be the preferred site. Putting a "country park" into the plans will never replicate the current wildlife qe now have already in place.

Your views as made above will be considered before the application is determined.
