The applicants are aware that the present use of the site is governed by Policy GEN-3 (now CSP-1) and Policy GEN-7 (now DM-1) and wish to retain the key elements of the consents granted in 2012, namely -

> Residential: the existing dwelling house would remain unchanged as the applicants' sole residence. Studio 2 and its ancillary facilities would be converted internally into further residential accommodation for the applicants' family. A new porch connecting that building to the existing dwelling house would be constructed.

> Live/work: Studio 1 would remain unchanged and become an artisan workshop for the applicants' own use.

> Commercial: Studios 3-6 would remain unchanged and would continue in their present use as tenanted artisan workshops.

Apart from the construction of a new porch, the external envelopes of all buildings on the site would remain unchanged.
