

Dear Mr & Mrs von Rietberg,

I am emailing today with regard to the above application and CIL.

You indicate that you are converting existing buildings. To enable me to deduct this floor space, you must provide proof that it has been in lawful use for a continuous period of 6 months within the last 3 years. Utility bills, council tax bills and sworn statements are forms of acceptable proof.

As the building is included in the site red edge of the dwelling house, utility bills for the dwelling suffice.

Once we have received this information, the CIL amount will be calculated on the small extension. As this will be a residential extension, you can complete a Form 9 Extension relief form (providing you fit the criteria on the form) and this will reduce the CIL Liability to zero. - [form 9 extension exemption claim.pdf](#)

This is entirely your decision. Please let me know how you wish to proceed.
