Thank you for your internet representation made on 17th June 2025 which has been recorded as an objection with the comments as follows:

OWPC77215

I am concerned that the access road which is an unmade farm track is not suitable for the proposed increase in traffic which will come from this proposed development. This track is not maintained and will not cope with this increase in traffic. This farm track is a designated footpath, which increase traffic will place pedestrians at risk as there are no footpaths. This development is out of character for this residual area of old Sussex. I am also concerned that approval of this development will allow further development of this valuable green belt and prime farm land.

Your views as made above will be considered before the application is determined.
