Pre-App Response

If flood risk and biodiversity issues can be satisfactorily addressed, then the proposals would benefit from the presumption in favour of sustainable development, and it would likely be approved subject to conditions covering materials, biodiversity, trees/landscaping and highway matters. I anticipate that adverse implications would be identified in relation to landscape, trees and the Gap location. However, as these are all issues capable of mitigation through suitably worded planning conditions, I consider that they would not be sufficient to outweigh the presumption in favour of development that would apply here. Notwithstanding the above, there are a number of detailed points identified in this advice that must be addressed in your submissions in order for them to be supported and planning permission granted.

Planning Application - LU/157/23/PL

Application was refused on the following grounds:

1. Insufficient information has been provided to justify the unacceptable level incursion into the Root Protection Area or to demonstrate the proposed development would not give rise to unacceptable harm to the protected trees on site. The proposal would therefore fail to accord with local plan policy ENV DM4.
2. Insufficient information has been submitted to demonstrate that the proposed development would not result in unacceptable harm to the ecological value of the site contrary to policies ENV DM5 and ENV SP1 of the Arun Local Plan, and the NPPF.
3. Insufficient information has been submitted to demonstrate if a policy compliant and sustainable surface water drainage scheme can be accommodated on the site alongside the proposed layout contrary to policies W DM3 and ECC SP1 of the Arun Local Plan and the NPPF.

We have now concluded the winter ground water monitoring for the drainage, which address reason No. 3 and we have adjusted the building positions to address conditions 1 and 2
