RE: LU/249/25/RES - Phase 6a Hampton Park, Littlehampton

Thank you for your consultation on the above site, received on 09 January 2026. We have reviewed the application as submitted and wish to make the following comments.

Approval of reserved matters following LU/47/11/ (amended by LU/182/15) comprising 288 No residential dwellings, the formation SUDs features, children's play space, landscaping, car parking, roads, landscaping and public access to the northern extent of the Black Ditch Open Space.

The applicant has provided sufficient information relating to surface water drainage that remains consistent with the information provided for the Outline planning application and therefore the details are in accordance with NPPF and local planning policies of Arun District Council.

We note outline planning permission LU/47/11/ (as amended by LU/182/15/) included conditions from your Engineers relating to the submission of full details of the proposed surface water drainage scheme (Condition 10) and implementation for the development.

Our review of the information provided to support Condition 10 is below. It should be noted that the information provided relates solely to the drainage features (SuDS) of the development and therefore the above review is based solely on this aspect of the development.

We have **no objection** to this Reserved Matters application given the outstanding Condition associated has not yet been discharged.

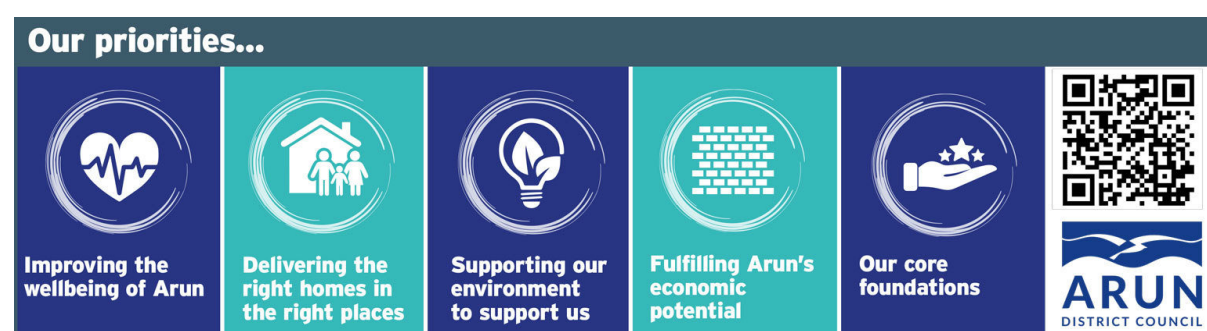
