The entrance and exit to the proposed community and additional living unit is a cocker to where it is planned and this road already suffers with parking problems and adding in another access point to this location would create a pinch point and moving this entrance to sit opposite the entrance to Barstow house flats would help the traffic flow nd reduce a pinch point
