Sorry I have just seen you email and for some reason I was not consulted for this one, but it is in my name ???

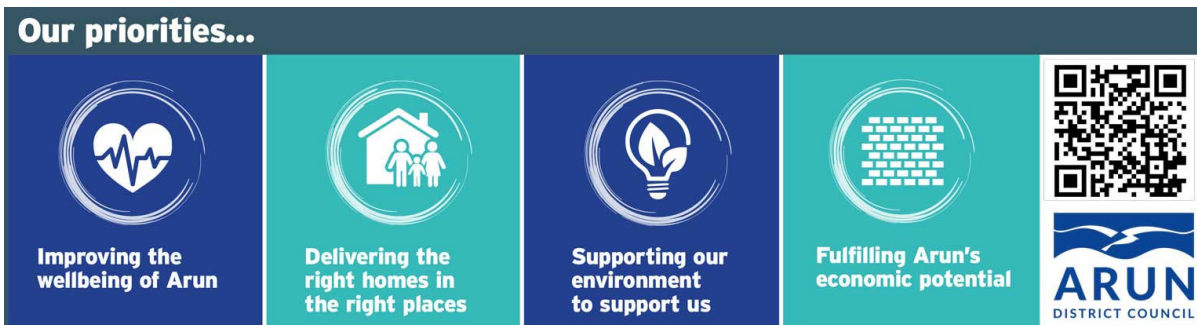
I have just checked the CMP and I'm happy with this as compliance only.
