The ground floor of the building has been in continuous use for light industrial purposes, specifically woodworking and joinery. While the original use class may have been B2, the activities over the past five years are more consistent with Class E (Commercial, Business and Service). However, this has not been formally reclassified. The existing use is considered potentially incompatible with the newly built residential dwellings adjoining the site.

The first floor is currently in use as residential accommodation, which was approved under planning application ref. LU/144/97.
