Thank you for your internet representation made on 24th June 2025 which has been recorded as an objection with the comments as follows:

I strongly object to this development. The road leading to this development, Toddington Lane, is effectively a 1 lane road due to on street parking from the homes already there. On top of this it's the link road to the 1200 homes of the Hampton Park development. As the council won't prevent street parking on Toddington Lane these additional homes will put more pressure on the single lane road. Also with 1200 homes already being built are another 30 really going to help. This devolpment will eat up some of the last green space around the north of Littlehampton. As Persimmon are not building the School these extra homes will put more pressure on local infrastructure and transport. Please will you say no to this.

Your views as made above will be considered before the application is determined.
