**Prior Notification of Work to Tree(s) in a Conservation Area**

**Development:** Tree 1 silver birch on south boundary wall. Crown reduction to 9 metres above ground level to provide clearance for overhead telephone cables. applica Currently approx 12 metres tall. Tree growing in to overhead telephone lines. Previously pollarded. Cut back in accordance with previous planning consent. Low amenity value.

Tree 2- Laburnham in front drive on north boundary wall. Crown reduction to 7 metres above ground level. currently approx 9 metres tall. Not growing well - possibly diseased. Application to reduce by 2 metres and reshape but if found to be diseased by tree surgeon, permission requested to fell and replace with same tree (Laburnham) or similar slow growing tree once ground is clear.
