To clad the top half of all walls of the house with either UPVC or Cedral Fibre Cement Weatherboarding to include new Fascias and Soffits. Colour to be decided, depending on restriction, but a very pale green or cream preferred.

My house is situated on the A27, on the border between Arundel and Lyminster and Crossbush and is just on the Lyminster side close to Arundel Station and by the Pelican Crossing near the Causeway Roundabout. The ditch running parallel to my garden is the Parish Boundary between Arundel and Lyminster. The house faces the A27. My house at the moment is fully rendered with K Rend in Cream. The render is very stained and the staining continues to return, even after cleaning. In order to combat this my proposal is to clad the top half of all the walls of the house with Fibre Cement Weatherboarding and to fit new Fascias and Soffits. The Colour of the cladding is to be decided, depending on any restrictions, but a very pale green or cream is preferred. Not only will the cladding cover over the stained render on the top half of the house, but I believe that it will enhance the appearance of the house too. The remaining render on the bottom half of the house walls will be easily accessed for cleaning and redecoration.

ADVICE

DESIGN AND VISUAL AMENITY

The site is a detached dwelling located just outside of the town of Arundel on the main vehicular road between the town and the railway station. The locality is dominated by the main road with a ribbon of residential properties and a hotel on the western side, facing open countryside across the road on the eastern side. The properties are located between the Arundel bypass roundabout and Arundel station. The application seeks to clad the top half of the dwelling with the addition of new fascia and soffits.

The dwelling is currently rendered with K Rend in cream and the proposal seeks to clad the walls (all elevations) of the dwelling with fibre cement weatherboarding in the colour pale green or cream. Both these colours would be considered an acceptable colour for the cladding proposed.

The changes proposed are cosmetic and would not have a significant impact on the character of the street scene. It is noted that the cladding to the walls of the dwelling would be a modern addition to the property, however it is not an uncommon feature within the wider area and would not be an incongruous addition in this instance as similar elevational treatment can be seen within the street scene. Arundel Park hotel which is located at close proximity to Arunbrook House features a similar elevational treatment.

The proposal is not considered to result in harm upon the character of the area and is therefore in accordance with policies D DM1 and D DM4 of the Arun Local Plan.

RESIDENTIAL AMENITY

Given the nature of works, the proposal would not result in any harm to neighbouring properties.

The proposal would not result in harm to the amenity of neighbouring properties by way of overbearing, overshadowing or overlooking and the proposal is therefore in accordance with policies D DM1 and D DM4 of the Arun Local Plan.

SUMMARY

The proposed alterations would not harm the character and appearance of the dwelling or the area in accordance with policies D DM1 and D DM4 of the Arun Local Plan. Additionally, the proposed works would not harm neighbouring residential amenity, in accordance with policies D DM1 and D DM4 of the Arun Local Plan. Therefore, were a formal application to be received for the proposal, it would likely be approved on this basis.
