Your appeal (under Section 78 of the Town & Country Planning Act 1990) would be that the Council has failed to make a decision and you would be asking a Government Planning Inspector to make the decision instead. If you allow the Council extra time to make a decision on your application, and you disagree with the decision, you will still be able to appeal within 6 months from the date the decision was issued.

This application may be CIL Liable and you are advised that you need to complete an assumption of liability form or any appropriate exemption or relief forms available on the Council's website.
