### Description

Please describe details of the proposed development or works including any change of use

This is an amalgamation of 3 terraced houses into 1 semi-detached house.

Ancton Lodge was built as a farming lodge in 1910 and was converted to 4 properties in the 1960s. We propose to amalgamate three of these properties back into one single property, opening up original passageways between the properties, respecting all remaining original features. This will create a home suitable for our extended family and also provide a ground floor bedroom with ensuite should our mobility be reduced. Apart from the opening between the proposed kitchen and breakfast room no rooms or walls will be re-configured, as can be seen from the attached plans. We will be improving heat loss within the property by closing up some external doorways and fitting loft insulation throughout.

We originally purchased nos 3 & 4 Ancton Lodge on 15 March 2024 - they were advertised as one lot with vacant possession. We proceeded to connect these two houses into one internally, by re-establishing existing openings, as per the proposed plans for nos 3 & 4. We did not believe that we needed planning permission for this (I accept that I should have contacted the council to confirm) and had no intention of purchasing no 2 at the time.

Later in 2024 the executor of the owner of no 2 (who had died in 2023) contacted us and asked whether we would be interested in purchasing no 2. We agreed and completed the purchase on 1 October 2024. We proceeded to connect nos 2 & 3 as per the proposed plans and then were advised that we should seek planning permission. We thus stopped any further works and sought this application.

I hope that you can accept that proceeding with the work without permission was an honest mistake on our part.

It is also proposed to remove the front door of no 3 and replace it with a FENSA-approved window with the lower part of the door opening blocked up with thermalite blocks, insulation board and plasterboard internally with render and pebbledash finish externally to match existing walls.
