Further to our previous comments concerning the extent of any proposed demolition, it is clear from the supplementary drawings showing the overlay of the proposed and existing dwellings, that the application description is incorrect. This should now be revised and resubmitted making clear that it includes the demolition of the existing property.

Your views as made above will be considered before the application is determined.
