Description of works: Change of use from beach to garden and erection of a 3' single post and rope fence. This application is in CIL Zone 4 (Zero Rated) as other development.

Thank you for your internet representation made on 5th January 2025 which has been recorded as an objection with the comments as follows:

I object to the change of usage from beach front to exclusive use for the applicant's Air B&B, even though she has had to apply for change of use in retrospect. appreciate that the owner owns the land to the "high tide level" but this land has been left open for considerable years and the "high tide level" is pushing back towards her property and will continue to do so with climate change and rising sea levels.

The West Sussex Way footpath runs along this stretch of beach and was agreed with the owners of the beachfront properties long before the applicant started buying sea front properties in Middleton and Elmer for the sole business use of Air B&B.

The applicant now owns three large Air B&B properties on Central Avenue and another on Elmer Sands Estate which sets a very dangerous precedent for the future of these properties and their beach frontage.

There has been destruction of the plants growing in the shingle on the applicant's land which has been fenced off. The local people that live here and support the village that makes such a lovely holiday experience for her clients, understand that this destruction of the foreshore is perilous and leaves local home more vulnerable to "overtopping" by future storm surges. The steps shown on the Land Registry document were just access to the beach, it was never fences off. The garden on this property that she rents out to at least 18 people is huge and ample for her business needs. I'm sure the applicant doesn't need to worry about the cost of her insurance as her clients are paying for it.

The applicant has acted without thought for the local people that live in the village and have been using this stretch of foreshore for decades.

As a post note, what does the applicant plan to do with these properties when the Council starts restricting Air B&B's as in other areas? I think exclusive flats with private beach access. Not good for locals and their housing needs. Arun D.C. please sit up and take notice.

Your views as made above will be considered before the application is determined.
