Dear Helen,

I thought I would just send a quick email regarding the above application and CIL.

Simon Davis has calculated the floor plans for the CIL purposes and there is quite a discrepancy on the totals from what is stipulated on the Form 1 Additional Information. It appears that you haven't included any of the garages.

We have these calculated as follows:

- 1 x quad garage type 1 at 110.2m²
- 1 x quad garage type 2 at 84.66m²
- 14 x double garages at 38.48m² each (538.72m² total)
- 21 x single garages at 19.23m² each (403.83m² total)

This makes the total CIL Totals -

Market Housing – 6962m² + 1138m² for garages = 8100m² total
Social Housing (awaiting forms) – 2312m²

Therefore, full total = 10412m².




