**Proposal: Raising of the roof and roof re-design with a side gable and a side dormer.**

**First floor rear balcony**

I refer to the above Application that the District Council has recently registered and as adjoining owner wish to make the following objections:

- The property is situated on the Pagham Beach Estate and the Directors would remind the District Council that this area is subject to a Policy restricting development to single-storey construction. This proposal is therefore in breach of this Policy and should be Refused.
- The proposal seeks to create a gable with side window on the east side of the building, which is an un-neighbourly proposal and will create overlooking to the adjoining property to the east. For this reason therefore, the Application should be Refused.
- The property adjoins the Upper Beach which is in the Company's ownership, down to Mean High Water. The District Council's records should show that this land is designated as part of Pagham Harbour SSSI. Notice of the proposal has therefore been referred to Natural England which administers the SSSI and they will no doubt wish to make recommendations to protect the designated area.

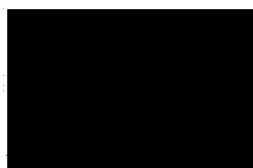
Please ensure that the Planning Committee is made aware of the Company's comments before they made their decision upon this Application.
