Thank you for your internet representation made on 10th January 2026 which has been recorded as an objection with the comments as follows:

We live over the back in lagoon Road and I am worried about the encroachment of the new extension works being submitted. At present we have a quite and private secluded rear garden, which is basically screened off by the garage, therefore removing the garage to build an extension will significantly change our view and privacy. When the property was built approximately 2001 about the same time as ours, the original builder was told he could only build what is actually there now, due to the limited size and constraints of the land. The existing garage forms part of that approved arrangement and currently provides an important buffer between our properties. We would like to make it clear that we are open to discussion and would welcome the opportunity to engage with the applicant to explore potential screening that would address the issues of overlooking privacy, and scale. We tried to get in contact, but the property is currently a rental so we have been unable to establish communication with the owner or applicant.

Your views as made above will be considered before the application is determined.

Please be aware that Planning Services operate an 'open file' policy and will publish your comments including your name and address on the website. Unlike all other types of appeal, there will be no further opportunity to comment at the appeal stage.
